TWO NEW KING'S COUNSEL

The appointment of two new King's Counsel was approved by the Governor in

Executive Council today. They are Mr. John William Durack and Mr. Francis Walpole Leake Mr. Durack, who is a member of the firm of Dwyer, Durack and Dunphy, is 50, and was born in Queensland.

With his parents he came to Western Australia as a baby. He was reared in the East Kimberleys where his father was killed by blacks.

by blacks. After attending the Christian Brothers' College, Perth, he was articled to Mr. M. L. Moss. K.C., now in England, and was admitted as a practitioner on August 15, 1913. During the war Mr. Durack saw service as a trooper with the 10th Light Horse. He now holds the rank of Major as senior officer in the Army Legal Corps here.

SON OF FORMER PREMIER

Mr. Leake, a member of the firm of Northmore, Hale, Davy and Leake, is three years older than Mr. Durack and was admitted to the Bar three years earlier—on March 15, 1910.

A west Australian, he is the son of the late Mr. George Leake, a former Premier of the State. An ex-pupil of the Hale School, Perth, the new K.C. also spent four years at school in Epping-M. Longhamy service with the

Mr. Leake saw service with the Australian Imperial Forces in France with the 28th Battalion, and later with the armoured cars. with the armoured cars. Other King's Counsel at present practising in Perth are Sir Walter James, Mr Norbert Keenan, MLA. Mr, Villeneuve Smith, Mr, H. P. Downing, Mr, H. B. Jackson and Mr. Ross McDonald, MLA. The Solicitor-General, Mr. J. L. Walter, is also a King's Counsel, as is Mr. W. F. Sayer, whom Mr. Walker succeeded in that position.




LIEUT. NEVILLE J. HEENAN, Awarded the Military Cross for putting out, single-handed, a fire in an ammunition dump. He is a member of the Australian Field Artillery, and is a son of Councillor M. J. Heenan, of Esperance, W.A.



'For conspicuous gallantry and devotion to duty. During a heavy bombardment of his battery a serious fire had broken out amongst the ammunition. The officers of his battery attempted to extinguish it, but the battery commander prevented them, considering the risk too great. Lieutenant Heenan, coming from another direction, did not hear this order, and extinguished the fire single-handed, and at the greatest personal risk from enemy shell, burning ammunition, and leaking gas shell, thereby saving a very serious situation, and setting a magnificent example to his men.'

FIVE AWARDS TO W.A. IN HONOURS LIST

Knighthood For Mr. Ross McDonald, K.C.

LONDON, June 7: Mr. Ross McDonald, K.C., was one of 11 Australians, and the only one in Western Australia, on whom knighthoods were conferred by the King in the 1950 birthday honours list. General Sir Thomas Blamey was promoted to the rank of field marsnal.

Other West Australians who received honours were Dr. J. S. Battye, who was awarded the C.B.E.; and Mr. F. W. Bateson and Miss Jessie Clifton, who received the M.B.E.

Mr. G. D. Henderson, an oral surgeon and radiologist, of Perth, was also awarded the C.B.F. for dental services to the plastic surgery unit at the Heidelberg military hospital, Victoria, during World War IL

King's Counsel Since 1936

Robert Ross McDonald, K.C., was born at Albany in 1888. He was educated at Scotch College, and subsequently studied law at the University of Adelaide. He was admitted to the Bar in 1910 and was appointed King's Counsel in 1936.

Enlisting as a private with the A.I.F. in World War 1, he served in France and Belgium. After the war he was for ten years a member of the Australian Military Force, during which time he commanded the 8th Battery, Field Artillery.

h. 1933 Mr. McDonald was elected to the Legislative Assembly for West Perth. From 1938 to 1946 he was parliamentary leader of the National mentary leader of the National Party (subsequently the Liberal Party), and during his period in Parliament held several portfolios. He resigned from ministerial-office in October last, and did not seek rz-election to Parliament this year. Mr. McDonald is a member

Mr. McDonald is a member and a former president of the Perth Rotary Club. He was for some time an honorary A.D.C. to the Governor (Sir James Mitchell). He is president in this State of the Australian Institute of International Affairs and of the Victoria League.

Active In Life Of State

Dr. James Sykes Battye is principal librarian and secretary of the Public Library. Museum and Art Gallery of Western Australia.

Bora in Victoria in 1871, he received his education at State schools and at Geclong College and the Melbourne University, where he graduated as Bachelor of arts in 1891 and bachelor of laws in 1893. In 1922 he received the degree of doctor of fletters and in 1943 the honorary degree of doctor of laws was conferred on him by the University of Western Australia.

In 1894 he accepted the position of principal librarian in Perth. In 1912 he also became Secretary of the Public Library Museum and Art Gallery











Harry Collier WARREN





